The President wants to thank all the members who participated with their presence or by proxy to the Assembly, helping to formalize and consolidate the work done, with the desire to fulfill that dream so much aspired. That dream is becoming a reality today, through the recognition of the international community and the UN. We do not want to be pretentious but we are on the right way. We face great obstacles and complications with tenacity and good will.

After 38 years of history the World Parliament gave life to the new Statute. The content is certainly revolutionary compared to the previous constitution. The new Statute is articulated, both in the distribution of powers than in the regulation, in line with the Inter-Governmental Organizations (OIG). We are now in line with the expectations of the UN. The Parliament of the World is not an NGO, but an OIG, which is a Intergovernmental Organization of States. As mentioned, the Parliament of the World is entering in a new era with a new vision and International collocation that will be difficult to challenge.

The Headquarters of the World Parliament was approved for New York City set, while in Italy it remains the representative office only.

The Assembly approved that each member by September 30, 2014 can send suggestions or improvement proposals to the Presidency of the IPSP for the modification of the Statute. These suggestions must be approved by the same Assembly. This is democracy.

Soon, every member will be aware about the news and will receive the new Statute approved by the members with the greatest margin, almost unanimously.

Only one member asked for the postponement to a later date. Also the new Statute will be published on the website www.parlamentomondiale.org and www.internationalparliament.eu

The members who request for it will receive a large dossier against lawyer Rosario Castellini and his accomplices, who from the beginning tried to impede the progress and evolution of the IPSP. By the content it will be possible to understand everything.

We do not want to be repetitive, now more than ever we need the help of each of you, without your input we will not be able to achieve the goals and the position that we have prefixed.
