- Verified the creation of a fake World Parliament MOFA, owned by dr. Haissam BOU SAID: www.facebook.com/groups/174641765904786 international parliament mofa. wordpress.com/ which creates discredit to these operators engaged in Diplomacy for Security and Peace;
- Considered the will of the Presidential Council to realize a real communication of Peace avoiding any confusion and misinterpretation, removing also all those members who cause disorder and that foment improperly public opinion for personal interest:

DECREED THAT

already suspended from any office and title by this Organization on 26.08.2014, ordered to return back the passport No .: AA0200438 expired on 09/08/2014 and warned to not maintain any position contrary to the decisions of the Presidential Council of the International Parliament for Security and Peace, from continuing to present itself as an effective member and from continuing to operate without any authority, title and power, is finally

EXPELLED

definitively and permanently by this Organization of States, with absolute prohibition of use letterhead, business cards, stamps and logos, release interviews or anything else that may refer to the International Parliament for Safety and Peace. Consequently, from today and under all purposes of law is made executive this present decree in any State of the World.
