## INTERNATIONAL ANNOUNCEMENT

To all Members, Political
Councilors, Ministers,
Ambassadors, General
Secretaries, Vice Presidents of

Rome, 27.12.2013

Following the resolution of the last 5 December 2013, by which the General Assembly of this organization approved important amendments to the Constitution and the election of the related members (see the copies of the reports which will be published in a few days on the web site <a href="www.parlamentomondiale.org">www.parlamentomondiale.org</a>), we announce the revocation of all previous political and diplomatic appointments, no one excluded, for the decision of the Supreme Council to let its mandate to the General Assembly's sovereignity. As a consequence, this Cabinet, the only authority now in office who was democratically and unanimously elected by the General Assembly in accordance with the Constitution, will convey the decisions about the reappointment of the members of the Supreme Council and of the political charges. Whoever would like to apply for an assignment within the directive, diplomatic or political authorities, or who has reached the legal rights to do so, will be required to send a specific official request so that his/her candidacy could be submitted to a regular election or rather to an appropriate evaluation by the constituting Supreme Council.

This President's Cabinet informs the members that the power of ordinary and extraordinary administration, to the purpose of the current Constitution, can be held only by the President in office, who is the only legally responsible person and therefore is the only one to have the power of attorney necessary to commit any current activity of this organization.

For greater clarity, **NOBODY** but H.E. the President can:

- 1) Ask for donations on behalf of the IPSP unless through the Ministry in charge (authorized by a specific decree);
- 2) Create or manage websites without an authorization issued by the President's Cabinet. The existing websites, even if not updated, will have to shut down by the 15 January 2014, with the possibility for the members who have been managing them and who would like to keep them, to send an official request to the President's Cabinet;
- 3) Use headed paper or stamps different than those established by the President's Cabinet;
- 4) Open bank accounts on behalf of or with reference to the IPSP;
- 5) Issue declarations to the press without authorization and before the announcement of the new appointments;

- 6) Use signaling disks such as "police" or similar without authorization because this is not within the IPSP's powers:
- 7) Use titles previously awarded by the IPSP which have now been revoked or cancelled and not reconfirmed. The new titles will be attained simultaneously with the confirmations or the new appointments.

If a member of the IPSP (indipendently from his/her office in the above-mentioned organization) acts against the instructions of the President's Cabinet, even if his/her actions do not cause any damage to the IPSP image or economic loss, he/she will be subject to disciplinary measures and, in the case of wilful misconduct, he/she will be prosecuted by civil and/or by criminal lawsuit.

This Cabinet has been receiving many warnings from all over the world regarding the illegal use of titles, passports, etcetera. This is not rewarding at all: many act only to gain their own personal advantage and this damages the IPSP image and credibility. Therefore, from now on it is not allowed to act and work without rules, superficially, on one's own.

As already said, the reorganization of the operational, political and diplomatic system of the IPSP is underway and since the next 2 January 2014 the new procedures will be effective.

We would like to inform again that who does not follow the rules will be subject to disciplinary action and, if responsible of wilful misconduct, could also be deprived of membership, with the related consequences.

By the second half of the month of January, every member will receive the forms for the confirmation of their membership which need to be filled out and sent back to the President's Cabinet, that is very concerned about the quality of the colleagues and about the restoration of the IPSP image.

We would like to take advantage of this opportunity to send to all of you our best wishes for a happy and prosperous new year 2014.
